

### TERMS AND CONDITIONS FOR CARICARI LISTINGS

This terms and conditions governs the access to CariCari Listings ("Platform"). You are deemed to have read and accept the terms and conditions (collectively referred to as "CariCari Listings Terms and Conditions") and consent to the processing of your personal data as described in <u>TM Privacy Policy</u>. TM reserves the right to vary, supplement, delete, amend or modify this CariCari Listings Terms and Conditions, from time to time without prior notice to the customer. You are responsible to check on the terms and conditions regularly. By continuous access to the Platform, you are agreeing to be bound by any modifications and amendments imposed on this terms and conditions.

## 1. GENERAL

- 1.1 The CariCari Listings ("Platform") brought to you by TM Technologies Services Sdn Bhd Company No. 200201003726 (571389-H) ("TM"), an online listing platform that connects consumers and Merchant seamlessly and is open for public access ("Visitor").
- 1.2 This Platform is offered together with Unifi Biz package subscriber whom are carrying a legitimate business in Malaysia and is a Malaysian citizen aged 18 years and above ("Merchant"). If you are under the age of 18 and have access to the Platform, you are required to obtain necessary consent from your parents or legal guardian for the purpose of personal data processing as described in TM Privacy Notice.

## 2. THE PLATFORM

- 2.1 As and when a Merchant become eligible to advertise in the Platform, you will be notified by TM to set up the listing. Merchant is responsible to provide information about the business. - 2.3 Where necessary, TM reserves the right to maintain Merchant's existing listing in the Platform upon the termination of the service with minimal information. In the event Merchant disagree for TM to continue publishing Merchant's listing in the Platform, Merchant may submit a written request for removal of the listing to TM via <u>listings.cari@tm.com.my</u>.



2.4 Merchant is entirely responsible for the business transaction with Visitor including but not limited to the business, goods, product quality, warranty of products and any other matters relating to the listing. All business transactions are solely between the Merchant and the Visitor and TM shall not be associated nor become a party in the transaction.

## 3. MERCHANT RESPONSIBILITY

- 3.2 Observe ethical business activities and adhere to the terms herein and TM's business policy and use the Platform for illegal and/or fraudulent dealings. Further, Merchant undertakes the listing do not have any connection in promoting and selling any counterfeit items. If Merchant breach this clause, or upon receiving any complaints from third parties regards to the above, TM shall have the absolute right to take down your listing from this Platform immediately.



# 5. PROHIBITION

- 5.1 You shall not advertise any item that is restricted or prohibited by the local laws. Below, we have listed a non-exhaustive list of some categories of prohibited items:
  - a. Animals and wildlife creatures
  - b. Antiques and Artifacts;
  - c. Controlled medicine and prescription only;
  - d. Drugs;
  - e. Unauthorized medical devices;
  - f. Hazardous chemical substances;
  - g. Counterfeit items;
  - h. Firearms and weapons;
  - i. Stolen goods;
  - j. Controversial publications which unauthorized to be sold in Malaysia including books, films, journals, and etc;
  - k. Alcoholic drinks;
  - I. Pornographic materials;
  - m. Illegal services; and
  - n. Any other items or services that are illegal and/or prohibited by laws.

#### 6. TERMINATION

- 6.2 However, TM has the right to conduct a continuous review from time to time on the listings and may delist the Merchant from the Platform if;
  - a. Contravene with any of the Platform's terms and conditions;

  - c. Upon complaints/request on grounds of intellectual property infringement;
  - d. Upon any request by the enforcement agency.

7.3 TM have right to process and use Merchant's information collected during the registration of services at the Platform. Displayed information will be limited to selected Confidential Information that deem to be necessary to fulfil our services.
